

Federal Direct Parent PLUS Loan Request Form

A **PLUS Loan** is a student **loan** offered to parents of students enrolled at least half time, or graduate and professional students. The original, now obsolete, meaning of the acronym was "Parent **Loan** for Undergraduate Students". Follow the steps below to apply:
 Step 1: The student must complete the **2019-20 FAFSA** (www.fafsa.ed.gov)
 Step 2: Complete and return this form (Parent PLUS Loan Request Form) to the Office of Financial Aid and Scholarships at the address above. Incomplete forms will not be processed. **Note:** *You can complete the Parent PLUS Loan Application through the Federal Direct Loan website at www.studentloans.gov. This will enable the U.S. Department of Education to perform your credit check and immediately inform you of the results.* **Please read instructions in their entirety.** PLEASE PRINT.
